



## Lancaster County 4-H Rabbit 2019 Calendar

- April 27** **SPRING 4-H RABBIT SHOW**—4-H Spring Rabbit Show will be held Saturday, April 27, 9 a.m. at the Lancaster Event Center – Exhibit Hall. Registration will be 7:30–8:30 a.m. Open to all youth ages 8–18. This is a great opportunity to learn and practice your showmanship.
- May 30 and June 6** **YQCA (YOUTH FOR QUALITY CARE OF ANIMALS) FACE-TO-FACE TRAININGS** — 6–7 p.m. at the Lancaster Extension Education Center, 444 Cherrycreek Road. See more information about YQCA below. Lancaster County 4-H/FFA youth may attend a face-to-face training on Thursday, May 31 or Thursday, June 7, 6–7 p.m. at the Lancaster Extension Education Center, 444 Cherrycreek Rd., Lincoln. To sign up for face-to-face trainings, you must go to <https://learngrow.io> before the training. The training will cost \$3 payable by credit or debit card on the website. We cannot take payments in person, all families must register and pay online. You must sign in as proof of attendance — certificates will be available online.
- June 8** **RABBIT TATTOOING & FAIR-PREP CLINIC** — 9-11 a.m. at the Lancaster Extension Education Center, 444 Cherrycreek Road. A rabbit tattooing opportunity provided by the Rabbit VIPs Committee. Cost is \$1 per rabbit. There will also be hands-on activities and help with paperwork needed for Lancaster County Super Fair.
- June 15** **ENROLLMENT DEADLINE** — 4-H members and volunteers must re-enroll every year online at <https://ne.4honline.com>. Only parents/guardians may enroll 4-H members. Each 4-H household will need to set up a profile in which the 4-H youth and/or volunteers in the household will be added. More details and step-by-step instruction guides with pictures are at <http://lancaster.unl.edu/4h/club>. Project area(s) each member plans to enter at the Lancaster County Super Fair must be listed.
- June 15** **ID FORMS DUE** — If showing at the Lancaster County Super Fair, “Nebraska 4-H Rabbit Ownership Affidavit” paper forms must be submitted to the Extension office. Forms are available online at <http://4h.unl.edu/animalscienceprogrammanagement> and at the Extension office. The form requires both the 4-H member’s signature and the signature of the parent/guardian. State Fair does not require a separate ID form, however, tattoo must be listed during the entry process.
- June 15** **YQCA (YOUTH FOR THE QUALITY CARE OF ANIMALS) TRAINING DEADLINE** — 4-H members showing any rabbits at the Super Fair or State Fair must complete Youth for the Quality Care of Animals training by June 15. Youth must be currently enrolled at <https://ne.4honline.com>. In Lancaster County, youth may choose one of three options to complete YQCA requirements:
- Complete online training at <https://yqca.learngrow.io>. Cost is \$12. For directions and more information, visit <https://4h.unl.edu/yqca>. Once training is complete, send completed certificates to Heather at [heather.odoski@unl.edu](mailto:heather.odoski@unl.edu) or 444 Cherrycreek Rd., Ste. A Lincoln, NE 68528. If certificates are not submitted, we have no way of knowing if trainings have been completed.
  - Attend a face-to-face training held Thursday, May 30 or Thursday, June 6, 6–7 p.m. at the Lancaster Extension Education Center, 444 Cherrycreek Rd., Lincoln. To sign up for face to face trainings, you must go to <https://learngrow.io> before the training. The training will cost \$3 payable by credit or debit card on the website. We cannot take payments in person, all families must register and pay online. You must sign in as proof of attendance — certificates will be available online.

- June 18–July 1** **ANIMAL ENTRIES (INCLUDING RABBITS) FOR THE LANCASTER COUNTY SUPER FAIR MUST BE SUBMITTED** online at <https://lancaster.fairmanager.com> between June 18 and July 1, 11:59 p.m. Only rabbits listed on an ID form can be shown at the Super Fair. The tattoo number must be listed when entered. No late entries accepted.
- Aug. 1–4** **LANCASTER COUNTY SUPER FAIR** — at Lancaster Event Center. All rabbits must have a permanent tattoo in the left ear. Tattoos must be in place before check-in. If rabbit does not have a permanent tattoo at check-in, it will not be eligible for showing and must be removed from the fair grounds. Rabbit tattooing will not be allowed on the fairgrounds.
- Aug. 10** **STATE FAIR ANIMAL ENTRIES DUE** — State fair entries must be done online at <http://nebr.fairwire.com> by the 4-H member/families. Nebraska State Fair does not require a separate ID form, however, tattoo numbers must be listed on the entry form. You may list/ID ten rabbits, but only five of those listed can actually be shown.
